# UNDERGRADUATE INTERNATIONAL SUPPLEMENTAL APPLICATION

## INSTRUCTIONS

- International students need to apply to Oakland University by completing an online application for admission at [oakland.edu/apply](http://oakland.edu/apply).
- Online applications may be submitted 12 months prior to the student's expected start date at Oakland University, but must be complete by the deadlines listed below.
- Applicants must also submit all of the required documents in this Undergraduate International Supplemental Application.

## MATERIALS REQUIRED FOR ALL APPLICANTS

- Online application (found at [oakland.edu/apply](http://oakland.edu/apply))
- Undergraduate International Supplemental Application
- Copy of passport
- Proof of English Language proficiency

### Additional materials required only for applicants who have attended a university or college outside of the United States

- A course-by-course transcript evaluation by World Education Services (WES) or Educational Credential Evaluators (ECE) for all coursework at colleges or universities attended outside of the United States. Submit via [wes.org](http://wes.org) or [ece.org](http://ece.org). Exceptions may be made for students who submit transcripts in English.

### Additional materials required only for applicants who have attended a university or college in the United States

- Official transcripts from all U.S. colleges or universities attended
- International Student Transfer Form (see page 4)
- Copy of SEVIS I-20 or Department of State DS-2019

### Additional materials required only for applicants who want to bring dependents on an F-2 visa (spouse and children only)

- Copy of passport for spouse and each child
- Please note that when financial documentation is requested, additional financial support is required for dependents (see page 5).

Once admitted to the university, all applicants are required to submit the Statement of Finances and supporting financial documentation before an I-20 can be issued. See pages 5 - 7 for more information.

If you are admitted to Oakland University, a welcome packet and further instructions from the International Students and Scholars Office (ISSO) will be mailed to you. This packet will include your immigration documents, orientation and housing information, and SEVIS I-901 submission instructions.

# INSTRUCTIONS FOR INTERNATIONAL STUDENT STATEMENT OF FINANCES

Before Oakland University reviews an international student application for admission and issues a "Certificate of Eligibility for Nonimmigrant Student Status" (SEVIS I-20) for a student visa to enter the United States, the applicant must provide documentation (bank statement, scholarship letter, etc.) to cover the following:

1. All tuition and **living expenses** for one academic year (8 months) based on out of state rates
2. Funds to purchase Oakland University **health insurance** required for all international students

**NOTE: ALL DOCUMENTS SUBMITTED WITH APPLICATION MUST BE NOTARIZED OR CERTIFIED, WRITTEN IN ENGLISH AND FUNDS CONVERTED INTO U.S. DOLLARS.**

## ESTIMATED TUITION AND LIVING EXPENSES

The above estimated fees and expenses are effective for the 2018-2019 academic year (September 1, 2018-April 30, 2019). Tuition and expenses are subject to change at the discretion of Oakland University. Please note that some students take more than 12 credits per semester resulting in a higher tuition cost, however you are only required to take 12 credits per semester to remain full time.

This total does not include books, supplies, miscellaneous expenses, living expenses for the periods when on-campus housing is closed, for any family member who will accompany the student, and all round-trip transportation expenses between the student's home country and Oakland University.

## BOOKS, SUPPLIES AND MISCELLANEOUS

The above estimate does not include an amount for books, supplies and miscellaneous costs (ex: cell phone, internet, transportation, etc.). The estimated cost for these expenses during an academic year is \$4,000. **It is highly recommended that each student has at least an additional \$4,000 available to purchase these items throughout the academic year.**

## STUDENT HEALTH INSURANCE

All F-1 and J-1 international students are required to enroll in the Oakland University Student Health Insurance Plan administered by UnitedHealth Group. Please do not purchase health insurance in your home country. All health insurance plans must be compliant with the U.S. Federal Health Care Reform Law (also known as the Patient Protection and Affordable Care Act (PPACA)). Please visit [oakland.edu/student insurance](http://oakland.edu/student%20insurance) for complete information on insurance policy requirements.

## DEPENDENTS

If students are accompanied by dependents (spouse or child/children), please add \$6,500 in U.S. dollars per year for the first dependent and \$4,900 in U.S. dollars for each additional dependent to the estimated tuition and living expenses above. In addition, please list all accompanying dependent names on page 2 and attach a copy of each dependent passport.

## FINANCIAL ASSISTANCE AND SCHOLARSHIPS

International students do not qualify for financial aid. Citizens of Canada and Mexico may qualify for the Non-Resident Award.
