A Recommendation

- 1. <u>Division and Department:</u> University Advancement.
- 2. <u>Introduction:</u> Every gift makes a difference at Oakland University. - **5.** <u>Educational Implications:</u> Some gifts are designated to fund specific academic programs.
- **6. Personnel Implications:** Some gifts may be used for salary or support.
- 7. <u>University Reviews/Approvals:</u> All gifts are processed by the Office of Advancement Information Services and are reviewed by the Vice President for University Advancement, prior to submission to the Board to ensure compliance with federal and state laws and regulations and University policies and procedures when applicable, with assistance from the Office of the Vice President for Legal Affairs when requested.
