# APPOINTMENT OF THE EXECUTIVE VICE PRESIDENT FOR ACADEMIC AFFAIRS AND PROVOST A Recommendation

- 1. <u>Division</u>: President, Academic Affairs, Office of the Executive Vice President for Academic Affairs and Provost and Human Resources.
- 2. <u>Introduction</u>: Dr. Amy Thompson obtained her Ph.D. in Health Education and a Master of Science and Education in Public Health from the University of Toledo, and a Bachelor of Science in Community Health and Health Promotion from Central Michigan University. She has earned numerous awards and honors during her career, including serving as the President of the National Health Education Honorary Society, Eta Sigma Gamma, and President of the Society for Health Education.

Professor Thompson held tenure-track faculty positions at Mississippi State University and Kent State University prior to becoming a tenured Full Professor at the University of Toledo in 2008. Since 2018, Professor Thompson has held upper-level academic administrator positions with increasing levels of responsibility. She served as the Vice Provost for Faculty Affairs at the University of Toledo from 2018-2020, prior to becoming the Senior Vice Provost of Academic Affairs and Acting Dean of the College of Graduate Studies. In 2022, Professor Thompson became the Provost and Senior Vice President of Academic Affairs at Wright State University.

In her role as the Provost at Wright State University, with an operating budget of over \$100 million, she oversaw six colleges, a medical school, a branch campus in Celina, Ohio, the Office of Research and Sponsored Programs, University Libraries, and Counselling and Wellness Services. She has demonstrated her talent in academic leadership by leading numerous significant initiatives that resulted in increasing research funding by 18% in one year, a 30-year multi-million-dollar collaboration with Premier Health to benefit health programs, millions of dollars of scholarship funding for students, and increased government and donor funding to support programs and research facilities. During her time as Provost, new student enrollment grew by 44% as the university introduced new programs in aviation, health, and engineering. She has led initiatives to improve student success by overseeing changes to the core curriculum and launching new industry-aligned micro-credentials. By holding various administrative positions in the Provost's Office both at the University of Toledo and Wright State University, Professor Thompson has developed a deep knowledge of all aspects of academic leadership, including faculty success, student success, accreditation, financial management, and fundraising.

Professor Thompson's impressive administrative background matches her academic scholarship. Over a 20-year period, she has addressed issues in public health related to health equity, mental health, firearm violence prevention, and cancer survivorship. She has authored a book on gun violence and published over 50 peer-reviewed journal articles. Her research has been presented in over 100 international and national conferences. She has received over \$1.7 million in grant funding to support her scholarship and programs.

The President has consulted with all University constituencies and recommends the appointment of Dr. Amy Thompson to the position of Executive Vice President for Academic Affairs and Provost.

An Employment Agreement between Dr. Thompson and Oakland University was reviewed and approved by the Office of the Vice President for Legal Affairs and General Counsel prior to its execution, is in compliance with the law and Oakland University's policies and regulations, and conforms to the legal standards and policies of the Vice President for Legal Affairs and General Counsel. The Employment Agreement is contingent upon the approval of the Board of Trustees.

- 3. **Previous Board Action:** None.
- **4.** <u>Budget Implications</u>: Funding for the Executive Vice President for Academic Affairs and Provost position is included in the General Fund Budget approved annually by the Board.
- 5. <u>Educational Implications</u>: Appointing an Executive Vice President for Academic Affairs and Provost will enrich academic and administrative leadership at Oakland University. The Executive Vice President for Academic Affairs and Provost will be the University's chief academic officer with general responsibilities for the University's academic programs, personnel, and resources. The Provost has direct oversight responsibility for the College of Arts and Sciences and the Schools of Education and Human Services, Business Administration, Engineering and Computer Science, Nursing, Health Sciences, the Oakland University William Beaumont School of Medicine, the University Libraries, and other divisional units.
- **6. Personnel Implications:** The personnel implications are as outlined in the recommendation below.

### DR. AMY THOMPSON

Dr. Amy Thompson serves as the Provost and Senior Vice President of Academic Affairs at Wright State University, where she oversees six colleges and various units including the Boonshoft School of Medicine, Lake Campus in Celina, Research and Sponsored Programs, University Libraries, and Counseling and Wellness Services. Prior to joining Wright State University, she held positions at The University of Toledo, including Senior Vice Provost of Academic Affairs, Acting Dean of the College of Graduate Studies, and Vice Provost of Faculty Affairs.



In her role as Provost, Dr. Thompson has spearheaded significant initiatives aimed at enhancing student success, such as establishing a new College of Graduate Programs and Honors Studies, launching a Center for Health Professions, implementing required midterm grades, and introducing a multiterm registration process. These efforts have contributed to improved academic performance and retention rates. She has also worked to modernize academic and curricular programs and to integrate a new workload recognition policy.

Dr. Thompson is a Certified Health Education Specialist and a Fellow of Eta Sigma Gamma, the National Health Education Honorary Organization. She co-founded and directed the UToledo Center for Health and Successful Living—an interdisciplinary community engagement hub that has delivered prevention-based programming and mammography services to over 7,000 individuals in Northwest Ohio.

In recognition of her outreach efforts with underserved cancer survivors, she received the Dorothy Green Medical Mutual of Ohio Achievement Award in 2019. Additionally, Dr. Thompson leads the Wright State and Community Partners Mental Health Task Force.

As a prominent figure in her field, Dr. Thompson has held leadership positions, including national president of the Eta Sigma Gamma Professional Health Organization and the Society for Public Health Education (SOPHE). She is also a Professor of Public Health in the Boonshoft School of Medicine, having published over 80 peer-reviewed journal articles and secured more than \$1.7 million in grant funding while sharing her scholarship at national and international forums.

Dr. Thompson's educational background includes a B.S. in Public Health from Central Michigan University, an M.S.Ed. in Public Health, and a Ph.D. in Health Education from The University of Toledo.
