CAMPUS PLAN 2035 A Recommendation

- 1. <u>Division and Department:</u> Academic Affairs, Finance and Administration, Facilities Management
- Administration authorized the engagement of the architecture and planning firm of Arcadis to facilitate a collaborative and comprehensive campus planning effort. The Campus Plan 2035 (Plan) creates a framework for Oakland University's Strategic Vision 2030 for the next ten years and beyond considering the enrollment, economic, social, cultural, and technological shifts facing the institution. The Plan recommends land use strategies, building re-use opportunities, new facility locations, infrastructure and technology improvements, parking, wayfinding, and multi-modal traffic flow that will strengthen the overall physical campus. The Plan incorporates input and priorities of many stakeholders including academic and student life for the campus while embracing the University's rich heritage.

In the Request for Proposals for an architecture and planning firm to facilitate development of Campus Plan 2035, the project purpose is stated as:

• The purpose of the Oakland University Campus Master Plan [Campus Plan 2035] is to support achievement of the University's Strategic Vision and objectives. The Master Plan must help differentiate the University and recognize it as a distinctive destination - with outstanding academic programs, a vibrant campus life, and a compelling physical presence. Further, the Master Plan must be developed in the context of Oakland University as a 21st century university including stewardship for sustainability and carbon reduction on campus. Moreover, the Master Plan will provide a basis for coordinating physical and programmatic development decisions, providing a framework for long and short-term planning that is clear and flexible – responding to changing needs and conditions. It will also help guide development of a strategic, prioritized Capital Outlay Request.

- **5.** <u>Educational Implications:</u> All components of the Plan have some form of educational impact such as enhancing enrollment, retention, and graduation rates through a series of physical improvements such as upgraded or repurposed facilities, and wayfinding and movement throughout campus.
- 6. Personnel Implications: None.
- 7. <u>University Reviews/Approvals:</u> In order to ensure broad campus input into Campus Plan 2035, the Steering Committee and Arcadis consulted with students, alumni, officials from local municipalities, employee groups, major academic units, Deans, University Senate, the President's Cabinet, and the President.
